PETITION FOR ORDER AUTHORIZING USE OF EAVESDROPPING DEVICE

Petitioner, Det. Scott Golike, Alton Police Department, being duly authorized by the State's Attorney of Madison County, now appears and makes application to a Circuit Judge of the Circuit Court of the Third Judicial Circuit of Illinois, and requests the issuance of an Order Authorizing the Use of an Eavesdropping Device. In support of said Petition, it is stated:

(1) That based upon the below-listed information, there is reasonable cause to believe that an individual is committing, has committed, or is about to commit a felony, being Obstructing Justice, Communication with a Witness, in violation of the laws of Illinois:

On October 02, 1999, Kenneth Spann was shot and killed in Alton, Madison County, Illinois. Valdez Jordan has been identified as the person who committed the robbery and murder. Valdez Jordan has spoken with Demond Spruill and admitted the commission of the murder and robbery. Jordan has stated that the murder weapon is being hidden by Shorty-four (unidentified as of this time). Jordan has discussed with Demond Spruill to setting up a three way telephone call between Jordan and others. They may discuss the location of the weapon and other

circumstances of the offense. They may also discuss contacting witnesses to influence the witnesses not to cooperate with this police investigation.

(2) That based upon the below-listed information, there is reasonable cause to believe that particular conversations concerning said felony offense will be obtained through the use of an eavesdropping device:

Valdez Jordan is in custody in the Madison County Jail. He has suggested to Demond Spruill that Spruill contact witnesses to the killing on October 02, 1999 of Kenneth Spann. Jordan has stated that Shorty-four has possession of the murder weapon. Shorty -four is unidentified at this time. During conversations with Spruill, Jordan has stated that he killed Kenneth Spann. Jordan has requested Spruill to contact Gardell Ballinger to find out what his testimony will be regarding the murder and attempt to influence the testimony of Ballinger. Jordan has requested Spruill to engage in three way conversations regarding the commission of the offense of murder.

- (3) That the type of communication sought to be monitored is telephone conversation and three way telephone calls.
- (4) That Demond Spruill and/or Jason Simmons is the party to the expected conversation consenting to the use of an eavesdropping device (see attached written consent form).
- (5) That Valdez Jordan and possibly Shorty-four AND OTHER PERSONS UNKNOWN AT THIS TIME are the persons whose conversations are to be overheard by the eavesdropping device.

- (6) That the time period requested for authorization for use of an eavesdropping device is from 2:00 p.m. on October 26, 1999 until 2:00 p.m. on November 09, 1999.
- (7) That the nature of the investigation is such that based upon the below-listed facts establishing reasonable cause to believe that additional conversations of the same type will occur thereafter, the authorization for the use of the eavesdropping device should not terminate automatically when the described type of communication is overheard or recorded.
- (8) That Petitioner knows of no previous applications to a Judge requesting permission to use an eavesdropping device involving the same persons as in the present application.



On the above date and time Sgt. Adams, Detective Franke, Detective Golike and this Detective, from the Alton Police Department, participated in a court authorized eavesdrop operation at the Illinois State Police District 11 headquarters in Collinsville, IL. Arrangements were earlier made to conduct an eavesdrop operation at the Illinois State Police Headquarters to utilize a covert phone line in this operation. The covert phone line is listed to a fictitious person identified as ROBERT NIX with a phone number of 344-5721. The purpose of this operation is to function as an associate of a C/I in the case and to set up a three (3) way telephone call between the suspect in the case, identified as VALDEZ JORDAN, and other persons JORDAN wished to contact. On 10/26/99 at 1600 hours, Alton Police Department eavesdrop equipment was set up and a leader was placed on the eavesdrop tape by Sgt. Adams. At 1739 hours the C/I in this investigation contacted this detective and a three (3) way telephone call was attempted on phone number 462-8972 at the request of JORDAN. However, this number was disconnected. A three (3) way telephone call was then attempted at phone call was then attempted at the request of JORDAN had a lengthy conversation with the subject identified only as "L.A." and two (2) female subjects. The overhear was concluded at approximately 1750 hours. This eavesdrop tape was labled as exhibit T-1, tagged as evidence and later placed into evidence locker #2 at Alton Police Headquarters. At this time the investigation continues.
